# Terms and Conditions

# 1. Eligibility

#### 2. How to Enter

Access to the contest "Hannover Messe - Register for a free ticket with the Eldon code & join the contest" is obtained by visiting the Eldon website at https://www.eldon.com/ or http://tradeshows.eldon.com/ and registering for a free ticket to the Hannover trade show. You will be redirected to the Hannover Messe website and asked to provide your details in a Registration form. Complete the full entry form, supply all your details and click "Register". Note that we will require your full mailing address and telephone number to contact you, should you be selected as a winner.

By entering the contest, the contestant consents to the public disclosure of his/her name.
